Major activities in the 2nd Reporting period are Activities 1 and 2, namely:

Activity 1

- Educational program, such as work with PhD and Volunteer;
- Arrangement of the local webpage.

Activity 2

- Participation in all actions within Activity 2: data, terminology and methods collation and harmonization, arrangement of field work, collection of new data including sampling and sample processing;
- Work on database aimed at storage, sorting and, particularly, analysis of data;
- Planning on current and future activities, such as correspondence with the staff and project partners and meetings;
- Contacts and arrangement of service/research from external organizations to fulfil field work and fill in the gaps in data;
- Co-operation with other Project Partners.

Collection of preliminary data on hazardous substances and nesting birds.


Major results and outputs of the 2nd Reporting period:

Activity 1


- The project staff is completely involved into the project actions; the system of Project management developed during the 1st Reporting period is tested;
- All Agreements and Contracts necessary to fulfil the tasks of the 2nd reporting period are made, the purchases (2) are done;
- Three representatives of project target groups are involved into the Steering Group of TOPCONS;
- Expenditure verification for three Russian PP is arranged;
- ROM Monitoring action is assisted, including meeting at premises of Associated partner 1;

Activity 2

- Sampling strategy for field guide preparation and field work implementation is elaborated, according to specificity of certain subareas and transboundary aspects, and tested on the examples of project Subareas 1 and 3, results are available for Associated partner-1;
- New data have been collected at project Subareas 1 and 3, including those collected for the first time;
- Arthedian database is adopted for TOPCONS needs and posted for comments to "Livelink";



- Description of field work is prepared;
- Description of integrative approach to field sampling and estimation of the modern state of human impacts and diversity of an ecosystem based of spatial and contact data is prepared.



Activities 3 and 4 are in progress.
